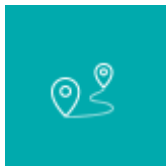

At the state ferry ports of Split and Zadar and on the following state roads:- on the part of the state road D8, on the route: intersection with D40 (Bakar junction) - Zadar - Split - border crossing (hereinafter: GP) Klek - (BiH border) - GP Zaton Doli (BiH border) - Dubrovnik - GP Karasovići (border of Serbia and Montenegro), except in the part from the intersection of the state road D27 (near Šibenik bridge) to the eastern entrance to Šibenik (branch for D58), and from the rotor Bilica in...

See general exceptions. In addition, the prohibition shall not apply to vehicles registered or people living in the zone of the state road D2 between Varaždin and Dubrava Križovljanska

Exceptions

The following vehicles are exempted from the prohibitions:

- vehicles with right of passage and vehicles under escort;
- vehicles of the Ministry of the Interior and of the armed forces;
- vehicles for maintenance of roads, electrical and similar installations, as well as vehicles for the distribution of mail and the press;
- vehicles belonging to radio or TV broadcasting companies;
- vehicles used for the transport of drinking water;
- vehicles transporting material or equipment for use in case of emergency;
- lorries or lorries with semi-trailers transporting concrete, asphalt or fuel for motor vehicles, except on the state road D2 between Varazdin and Dubrava Krizovljanska where they must comply with the traffic restrictions imposed under Article III of this order;
- lorries or lorries with semi-trailers transporting perishables such as fresh meat and fresh meat products, fresh milk and dairy products, fresh fish and fish products, perishable fruit and vegetables, except on the state road D2 between Varazdin and Dubrava Krizovljanska where they must comply with the traffic restrictions imposed under Article III of this order;
- lorries or lorries with semi-trailers transporting livestock or poultry, except on the state road D2 between Varazdin and Dubrava Krizovljanska where they must comply with the traffic restrictions imposed under Article III of this order;
- other licensed vehicles, only where, in view of the time and circumstances, the transport is particularly justified or strictly necessary for safety reasons, or because its delay would cause major material damage.

Additional information

Transit traffic of vehicles or groups of vehicles with or without cargo whose total weight exceeds 7.5 tons, and/or which are longer than 14 meters, must be carried out on specific public roads listed in the link below.
