Oggetto: Notizie in breve.

Tributi – Legge annuale per il mercato e la concorrenza 2023 – Vigilanza sui contratti assicurativi contro i danni catastrofali – È stata pubblicata sulla gazzetta ufficiale la legge sulla concorrenza 2023 che, in particolare, ha previsto che l'IVASS (Istituto per la vigilanza sulle assicurazioni) gestisca, anche attraverso la piattaforma informatica già disponibile per la comparazione delle offerte RC auto, un portale che consenta di comparare in modo trasparente i contratti assicurativi offerti dalle compagnie assicurative al fine di permettere alle imprese soggette all'obbligo di stipula dei contratti assicurativi a copertura dei danni ai beni direttamente cagionati da calamità naturali ed eventi catastrofali di compiere una scelta consapevole e informata; come è noto, la Legge di Bilancio 2024 (art.1 c.101-111 della L.n.213/2023) ha infatti previsto che tutte le imprese con sede legale o stabile organizzazione in Italia debbano stipulare contratti assicurativi a copertura dei danni a terreni e fabbricati, impianti e macchinari, nonché attrezzature industriali e commerciali causati da eventi catastrofali che si verifichino sul territorio nazionale (sismi, alluvioni, frane, inondazioni, esondazioni). Si segnala che, non essendo stato ancora emanato il decreto interministeriale MEF-MIMIT che renderà operativo tale obbligo il Governo con la recente approvazione del decreto di proroghe di termini relative a varie misure (di cui si attende la pubblicazione sulla gazzetta ufficiale) ha prorogato il termine di tale obbligo al 31 marzo 2025 – Art.22 della Legge 16.12.2024, n.193, su G.U. n.295 del 17.12.2024.

**Trasporti internazionali – Polonia – Obbligo di registrazione al sistema SENT dal 2025 –** Dall'1 gennaio 2025 le imprese di autotrasporto e di trasporto ferroviario comunitarie nonché dello Spazio economico europeo dovranno registrare le operazioni transfrontaliere relative ad alcune categorie di merci effettuate in territorio polacco sul sistema denominato *SENT* (Sistema di monitoraggio elettronico del trasporto); le suddette imprese dovranno registrarsi sulla piattaforma PUESC (<u>https://puesc.gov.pl/</u> con una versione di prova attualmente disponibile all'indirizzo <u>https://test.puesc.gov.pl/</u>) e completare la propria registrazione al sistema *SENT* (<u>https://puesc.gov.pl/uslugi/przewoz-towarowobjety-monitorowaniem-sent</u>) prima dell'ingresso delle merci nel territorio polacco; sarà possibile inviare i dettagli del trasporto fino a dieci giorni prima delle relative operazioni; la mancata registrazione al sistema *SENT* e la mancata o impropria dichiarazione della tipologia di trasporto effettuata comporterà l'applicazione di sanzioni pecuniarie ed eventuale fermo del veicolo.

**Autotrasporto – Piano Neve 2024-2025 –** È stato pubblicato ed è operativo il Piano di Viabilità Italia per gestire in modo efficace la viabilità nella stagione invernale e nell'eventualità di emergenze causate da precipitazioni nevose o ghiaccio; all'indirizzo <u>https://www.poliziadistato.it/articolo/1815cb58d622d6ac985858152</u> sono riportati le codificazioni dell'intensità delle precipitazioni nevose, la mappatura aggiornata delle aree

e dei nodi della rete stradale e autostradale più a rischio di precipitazioni, l'elenco dei tratti stradali e autostradali in cui vige l'obbligo di circolare con pneumatici invernali o di avere a bordo le catene da neve, le procedure da osservare in caso di pioggia ghiacciata (freezing rain), la ricognizione delle tratte autostradali e delle aree di stoccaggio (interne o esterne all'autostrada) per il fermo temporaneo dei mezzi pesanti, nonché ogni riferimento per rimanere costantemente aggiornati sulle condizioni di strade e autostrade e della relativa percorribilità.

Ciascuna impresa di assicurazione immette nel portale di cui al primo periodo il contratto assicurativo, conforme alle prescrizioni di cui ai commi da 101 a 107, indicando le condizioni generali, l'estensione delle coperture e la eventuali esclusioni e limitazioni. Con decreto del Ministro delle imprese e del made in Italy, su proposta dell'IVASS, sono stabilite le disposizioni attuative del presente comma».

# Notification of INTERNATIONAL ROAD TRANSPORT in the register of SENT declarations - RMPD Register (Register of International Road Transport)

When international carriage of goods by road as referred to in Article 28 (1) and (1a) of the Road Transport Act and cabotage transport as referred to in Article 29 is carried out by an entity established in a non-EU and EEA country, **the foreign carrier performing the transport**:

- on the basis of a permit to perform international road haulage;
- on the basis of a multilateral ECMT permit;
- without permit liberalised transport on the basis of bilateral agreements with the Republic of with the Republic of Poland or transports that do not require a permit, such as those performed under the Agreement between Ukraine and the European Union of 29 June 2022 *on the carriage of freight by road;*
- on the basis of a cabotage authorisation issued by administrative decision by the General Inspectorate of Road Transport.

# is obliged, prior to the commencement of transport within the territory of the Republic of **Poland**, to send to the register of notifications referred to in the SENT Act<sup>1</sup>, a notification of such transport.

According to the new regulations, the obligation to register in the SENT system will apply:

- **as of 1 November 2024** hauliers who are not established in an EU Member State, the Swiss Confederation or an EFTA Member State,
- **as of 1 January 2025** carriers from other EU Member States, the Swiss Confederation or EFTA Member States. These are entities that perform road transport on the territory of Poland to or from a non-EU country on the basis of a permit required by the provisions of an international agreement binding Poland and that country.

- **RMPD100** Registration of the notification of the carriage of goods
- **RMPD** Update
- **RMPD406** Checking the validity of transport report with last GPS position [RMPD]

- ✓ The procedure and the specimen of the document replacing the notification in Polish, Russian and English will be determined by the Regulation of the Minister of Infrastructure;

# NOTE!

- Failure to register the transport in question in the monitoring system may mean that the vehicle is stopped by the authorised services and financial penalties may be imposed.
- If a lack of declaration is identified during the movement of goods, the transport cannot continue without regularisation.
- Transports carried out without a SENT declaration will be treated as being performed without a permit for transport of goods by road.
